- Gary Gernandt Omaha City Council
  - o Marty Gray Public Works is retiring
  - o 25<sup>th</sup> &Vinton: application to start a new recycling center
  - o Convenient store application for 36<sup>th</sup> & Drexel
  - o  $32^{nd}$  & Q Bridge a huge amount of trees removed to make way for new bridge that will be put up in preparation for roundabouts at  $42^{nd}$  & Q
  - o Sewer Program is on budget and on schedule

o Neighborhood Grants released 2 weeks ago. Anyone can go online and submit an application. There will be a workshop on March 9 for interested applicants to receive mentoring and assistance with the application. The deadline is April 1 to apply.

## • Roger Garcia - Metro Board

O Getting into budget season and will approve the budget in late August or September. There is no inkling of increases. Recently, the board elected new officers to district committee and there are 2 representatives from South Omaha.

### Tony Vargas – OPS School Board

- o Board passed comprehensive sex education standards updates. OPS is engaging in community conversations at high schools to make sure parents are involved.
- o Board is still following through on bonds which means they are in process of buying and designing spots in South Omaha 60<sup>th</sup> & L High School and possible 2 elementary schools. Will start buying with the next bond.
- Workshops were held on 2 major issues: absenteeism and suspensions. District is working to improve multi-tiered programming to ensure students with behavioral problems are receiving appropriate supportive assistance.
- Nicole Fox State Legislature (Contact info: <a href="mailto:nfox@leg.ne.gov">nfox@leg.ne.gov</a>)
  - o 2 bills passed today:
    - Make insurance companies act quicker on appeals after the denial of a case.
      Current state law has a typo that gives them 30 extra days, and this bill corrects it.
    - o Make it easier for people who are engaged in natural hair braiding to open their own businesses.
  - o LB 1009: Deals with K2 or spice and would allow law enforcement/state regulators to identify copycat products. Fine would be implemented.
  - o Budget coming up and legislature going into all day sessions next week.
  - o If neighborhood members have any events are coming up, she will promote them on blog and push out through Facebook.

#### • Senator Mello - State Legislature

- o Senator is working on a number of bills including Infrastructure & Roads bill and securing funding for Offutt Levy Project.
- o Appropriations committee putting together a balanced budget and almost done
- o Bills passed: Landbank Statutes and Neighborhood Notification bill
- O Body-worn cameras Putting in place a regulatory framework for body-worn cameras used by law enforcement. Senator is currently working with the Crime Commission and OPD. This would be a framework so not all law enforcement agencies would have to do the exact same thing, but at least some standards of practice in place.
- O School Readiness Tax Credit package of tax credits aimed at helping lower the cost of child care and also increasing quality, especially for those who work in the child care work force who we know often aren't paid high salaries. These credits would help them as they move towards more advanced certification.
- o PACE Financing tool so that property owners can make energy efficiency updates to their property in a way that is more accessible and helps to secure financing to make those updates. The loan would stay with the property itself.
- Jim Rodgers Congressman Ashford (office number: 402-916-5678)

- Education Focus Week (2 weeks ago) Congressman met with groups of teachers from Douglas and Sarpy County and it provided him with information to take back to DC. He also met with superintendents from Douglas and Sarpy counties and culminated with an education seminar with 70 students from across the congressional district.
- VA is going to work on building a new facility where the currently facility resides.
  \$56 million has been allocated and \$80 million will be raised from here within the community.
- o August collaborating with USDA to follow up to sustainable urban agricultural seminar from last year and continue forward with more partners

- Young Professionals Summit was today. They had a community development track and everyone was talking about neighborhood associations.

- City Sprouts South There are multiple benefits of a community garden. Over the last year, the group has worked to develop the garden and host events such as the block party and the Halloween village. As of Jan. 1, 2016, \$50,000 was provided from the UNMC College of Public Health for the community garden project to use it as a platform for fostering health and community in South Omaha. This year, the group is planning on a series of community workshops in English and Spanish about cooking, nutrition, and gardening. Beds available in the garden for community organizations. Joel Cota will check with the city about putting up a sign that says "no vehicles" to keep vehicles off of the property.
