Police report – Police have had a baseball team in South Omaha with neighborhood kids. There has been a decrease in shootings.

Senator Mello – Legislature is investigating the Department of Corrections regarding the premature release of prisoners. The legislature is now starting interim studies and he asks that you contact his office with comments or concerns.

Councilman Gernandt – Graffiti survey is being conducted. He encourages you to call the Mayor's Hotline if you see graffiti. Brown Park baseball field has been renovated and is now open. The city council is working on the mayor's budget. The bicycle coordinator is a hot topic, there is some misinformation but they are looking for ways to have a coordinator with a different title. The council passed the land bank ordinance. It's another tool for improvement. There is an application for a market in South Omaha. There is opposition from out of state.

SOVIP – Received a grant from the mayor's office to do 4 community events this year. August 2, 2014 they had the first event which was a back to school bash it was a successful event. They gave away more than 200 backpacks. The committee meets the 2nd Wednesday of the month at the South Omaha Library at 11:30AM.

Neighborhood Alliances- Mayor has included 50K to support neighborhood alliances. Packets were distributed about the initiative and how it will be structured and evaluated. The money has been allocated, but not approved so neighborhoods are encouraged to reach out to elected officials to show support for the initiative.

Aksarben Elmwood Park got a matching grant for renovation of Schroeder-Vogel Park. Ribbon cutting is September. Tim Potter will verify date and time and it will be available on the website. There are multiple mural projects underway in South Omaha.
